We conducted 153 public educational activities.


- 7 **Personal Finance Courses** "take the course of your life" with 496 participants (8 sessions).

We collaborated with 63 alliances



1.Financial Access Fairs: the bridge between financial services and the community

The lack of knowledge about existing services deprives Hispanic families of Economic opportunities. For this reason, Qualitas of Life instituted the Financial Access Fair (FAF) to offer an effective bridge between trustworthy service providers and the Hispanic community. In 2022, Qualitas of Life conducted three hybrid Financial Access Fairs to connect local resources and communities in May, June, and October. These fairs brought together 318 families and 14 service providers. Moreover, the virtual fairs collected over a thousand views on Facebook. Thanks to our collaborators and sponsors of the Financial Access Fairs in 2022.

1.1 Third FAF: Hispanic Heritage Month "Participa, Aprende y Emprende"

Qualitas of Life celebrated Hispanic Heritage Month for the third year in a row with a three-day hybrid Financial Access Fair from October 13th to October 15th. The event gathered 260 families and over 1.1k views on Facebook. Qualitas of Life organized the participation of ten service providers, seven sponsors, and six local businesses for this fair. The Fair offered an opportunity to learn from experts about innovative ways to protect personal and family financial safety, fund a business safely in times of uncertainty, and take advantage of financial resources and tools from local partners. Furthermore, this event highlighted the entrepreneurial potential of Hispanic families and promoted the importance of supporting local Hispanic-owned businesses.



2.Familia Adelante: creating generational change

The Familia Adelante program has become a staple in Qualitas of Life partnerships. In 2022, Qualitas of Life celebrated the completion of the fifth year and the beginning of the sixth year of this family-led program alongside Mercy Center, Fiver Foundation for Children, and Mindfulness Practitioner Maritza Puello. The parents of Familia Adelante, who have received financial literacy, have gained the knowledge and confidence to make better and more informed financial decisions, from opening bank accounts, building credit, and paying taxes, to starting a business.

The families of Familia Adelante have become the leading multipliers of the benefits of financial literacy. Most of Qualitas of Life's activities conducted as part of the Familia Adelante program reported the highest participation.

2.1 Children's Day: Passing on positive financial habits

International World Children's Day raises awareness to advocate, promote and celebrate children's rights. Qualitas of Life Foundation has taken this cherished event to create awareness of the value of passing on positive financial habits from parents to their children. In June 2022, Qualitas of Life coordinated an interactive family-centered event for Familia Adelante families. The event gathered 38 families: 43 parents and 84 children. Qualitas Children's Day offers financial tools with a family-centered approach in a new, fun, and interactive way.

3. Personal Finance Program: Cultivating a solid financial foundation to ensure economic freedom

The Personal Finance program is the core program of our organization. This program offers essential financial tools in different formats to help individuals or families take control of their finances and build assets. In 2022, Qualitas of Life facilitated seven personal Finances courses (56 workshops) and 35 single-topic workshops to cultivate a solid financial foundation and promote the economic freedom of 3,844 families. Most of the sessions were offered remotely, although the return to face-to-face sessions was given priority. The courses and workshops were conducted in collaboration with 33 unique partners. This year, Qualitas of Life served the financial needs of new populations. We continue to expand our presence on the East Coast, and simultaneously, we are building upon our expertise to provide financial literacy with cultural and linguistic competence.

3.1 Short interventions: The outlet to return to in-person activities

Short interventions are key advice sessions that allow Qualitas of Life to strengthen its network of partners, create awareness of the benefits of financial literacy, and engage with participants in different forums. In 2022, short interventions were the outlet to return to in-person activities. We hosted and participated in 45 short interventions, 29 of which were in-person, for 1,863 individuals. Of these events, 11 were informational tabling events.



4. Financial Literacy Vendor: New innovative ways to promote financial literacy

4.1 New York Immigration Coalition

The collaboration with the New York Immigration Coalition is one of the most instrumental for Qualitas of Life in expanding financial literacy among the immigrant communities in New York. In 2022, we served as a financial vendor for the NYIC from February to June. This partnership reached over 389 individuals and had an estimated impact on 1,556 indirect individuals through 11 financial clinics, ten workshops, and three KTTC events.

4.2 Neighbors Link

In collaboration with Neighbors Link, we served as financial vendors to support beneficiaries of the Excluded Workers Fund through six specific workshops with 245 attendees from November 17th, 2021, to June 30th, 2022. This partnership allowed us to contribute to the road to recovery of those affected by the COVID-19 pandemic and who were left out of federal and state financial assistance. This project reiterates the importance of having an influential network of resources that can rapidly connect our community to financial resources.

4.3 Mastercard

In 2022, we supported Mastercard by developing a new financial guide tailored to Afghan immigrants. This financial guide has essential and general information on a range of financial topics with the potential to be disseminated to a broader community nationwide and targeted to benefit newcomers arriving in the country with a lack of understanding of the US financial system. The guide was published in early 2023.

4.4 Orca Loans (Orca Financial Education)

In collaboration with Orca Loans based in Colorado, we developed the first pilot program for Virtual Learning. The initiative aims to offer self-paced guided workshops for clients of Orca Loan. The project provides a baseline to utilize the expertise of Qualitas of Life and offers financial literacy in an innovative format for a broader audience. The pilot project is set to offer two topics on Budgeting and Credit and was launched during Summer 2023.

5. Entrepreneurship Program

The entrepreneurial potential among the Hispanic Community is a driving force of economic contribution and prosperous neighborhoods. In 2022, Qualitas of Life reaffirmed its commitment to offer a comprehensive entrepreneurship program that is culturally and linguistically competent and starts up our participants' entrepreneurial journey. We offered two courses of seven and ten sessions for 122 entrepreneurs.

6. Mentions and special collaborations

6.1 City of Aspiration: 150 ideas for building a more equitable NYC

Qualitas of Life Foundation was invited by the Center for Urban Future to participate in the report "City of Aspiration: 150 ideas for building a more equitable NYC," which provides a roadmap for how the city can become more equitable, with 150 New York-based leaders and national experts each sharing a single policy idea for what city officials should do to make progress towards a more equitable city.



Our Financial Education Program

Qualitas of Life Foundation's financial education program is designed to reach the broad and diverse Hispanic community through financial education on personal finances and entrepreneurship. Our program is tailored to meet the specific needs of each group we serve in partnership with strategic service providers.

Our financial education program is offered to the community in different formats, including workshops, courses, financial access fairs, short interventions, and printed and digital material to strengthen the financial capacity of the Hispanic community. In addition, Qualitas of Life Foundation also serves as a bridge between the participants of our programs and the trusted services they can access.



In 2022, we offered our program in the following formats:

- **Personal Finance Course:** Intensive readiness and asset building course consisting of eight 2-hour workshops. The course delves into seven core financial topics, from budgeting to fraud prevention. The course concludes with a general review session, a graduation ceremony, and a participation or completion certificate issuance.
- Entrepreneurship Course: Intensive entrepreneurship course consisting of seven or ten 2-hour workshops. The course delves into core entrepreneurial topics, the draft of a business plan using a user-friendly mobile application, and concludes with a general review session and the issuance of a participation or completion certificate.
- **Specific-topic workshop:** Up to 2-hour single-topic sessions designed and adapted to the specific financial community needs. The topics vary from the curriculum of personal finance topics from budgeting, money, migratory processes, and how to get ready to become a homeowner.
- Short interventions: Key advice sessions aimed at a diverse audience to offer essential information on the organization's mission or a specific financial topic or issue.
- Individual training sessions: Personalized sessions designed to set SMART financial goals based on individual and family needs. The goal is to equip participants with the tools to create better opportunities for themselves and their families.
- Financial Access Fairs: Events aimed to create a bridge between the Hispanic community and financial service providers and agencies with tailored services.

Fundraising Highlights

We fundraised a total of \$489,079 Securing over \$100,000 in sponsorships. Brands directly contributed to our fundraising efforts through different events:

1. MegaMex Foods: MegaMex more than doubled their 2021 contribution this sponsoring vear, now two Episodes of Qualitas en Mandil and Qualitas Talks. They also sponsored our Mezcal **Masterclass** and participated in the Financial Access Fair celebrating Hispanic Heritage Their sponsorship Month. was equivalent to 1,000 scholarships.

2. **Bimbo Bakeries USA:** Bimbo Bakeries doubled their 2021 contribution by sponsoring different episodes of Qualitas Talks, Qualitas en Mandil, and the Financial Access Fair celebrating Hispanic Heritage Month with a sponsorship equivalent to 900 scholarships. 3. **Aeroméxico:** They became an ally of Qualitas of Life by donating four round-trip tickets CDMX-NY / NY-CDMX to incentivize individual donations in our events. The tickets were promoted during Qualitas en Cultura with Prima Ballerina Elisa Carrillo and in Qualitas Talks with Sofia Kim to increase her fundraising for the Marathon.

4. **Tacombi:** A constant ally of Qualitas of Life, this year Tacombi donated 100 meals for the Financial Access Fair Celebrating Hispanic Heritage Month and 60 for the 5k race before the NYC Marathon.

We were also part of 8 corporate Matching Gifts programs.



Alongside our great team of volunteers, Friends of Qualitas, we carried out eight events:

- 1. Qualitas Talks on February 22nd. A fun and insightful conversation hosted by Fernando Rovzar & Luis García streamed on social media.
- 2. Qualitas en Mandil on February 23rd. A delicious culinary event hosted by Arap Bethke & Chef Ángel Vázquez streamed on social media.
- 3. Qualitas en Mandil on March 30th, hosted by Ariel López Padilla & Chef Roberto Santibañez, streamed on social media.
- Qualitas en Cultura on August 2nd. A cultural and distinctive event hosted by actor Ariel López Padilla & celebrated dancer Elisa Carrillo streamed on Facebook.
- 5. Mezcal Masterclass on September 14th, hosted by Gilbert Marquez in collaboration with llegal Mezcal.

6. **Qualitas Talks on October 4th.** A very special talk was hosted by Fernando Rovzar & Sofi Kim.

7. **5k Run on November 5th.** A beautiful community event the day before the Marathon, where the Hispanic community is invited to a walk/race at Central Park, accompanying Qualitas of Life's marathon runners to wish them good luck and cheer them on.


